PORTLAND OVATIONS Annual Board Meeting

MEETING MINUTES SEPTEMBER 22, 2021

The Board of Directors of Portland Ovations meeting was held September 22, 2021, at the Cumberland Club in Portland from 12 noon until 1:20 p.m. Lunch was provided. Board members also attended via Zoom.

Welcome Remarks: M.A. Lindemann opened the meeting by giving everyone in attendance the book "Create Dangerously" by Albert Camus and read the first two paragraphs. Copies will be available for those who did not attend the meeting in person.

M.A. Lindemann motioned for the Consent Agenda consisting of the September 22, 2021, agenda; and the Annual Meeting minutes from 6/16/2021 and 7/21/2021, 2021, be approved. All voted in favor.

C. Hughes presented the nomination of the new Board member S. Moudachirou. F. Knight moved to accept the nomination and vote S. Moudachirou to the Board of Directors. The motion was seconded by M. Boyson and all voted in favor. S. Moudachirou was invited into the meeting room for this meeting.

C. Hughes next presented the nomination of long time Board member M. Noyes to serve on the Executive Committee as VP at Large and will be working with P. Genova on the implementation of the Strategic plan. C. Hughes made the motion, seconded by T. Powers. All voted in favor.

M.A. Lindemann welcomed everyone to a new Board year. Portland Ovations is OPEN. We will do this safely and lift people up with live performances.

The report of the Executive Director A. Petrin started with the Land Acknowledgement

- It is looking to be an incredible year our 90th year of operation. The Screen to Stage video is available on the website the newly revamped website.
- People are thrilled and yet hesitant about coming back to live performances. Nationally sales trends show about a 20% drop and of the tickets sold about 20% do not show up or request refunds. This year the policy will be that everyone can exchange their tickets for another time or event.
- COVID protocols are being finalized and coordinated with the Portland City staff and the Symphony. Masks and vaccine proof will be the default. Negative rapid test results will be allowed, especially for young people not eligible for the vaccine. Ovations is looking into buying a batch of rapid home test kits with the Symphony as many performers are requiring this of contractors and backstage crews.
- Not all ushers have returned to their duties. The City will undertake security duties at the entrance to Merrill and other city owned venues. This includes checking vaccine cards and test results.

- We are finalizing the lease on the new Ovations home at 120 Exchange Street (on the corner of Exchange and Congress Street). The history of the building includes housing a theatre and UNUM's first headquarters. Renovations are underway to make the space usable. Ovations intends to move into the space with little furniture or walls and determine the needs over the following months. Standing desks and chairs will be the main furniture at the beginning. Final move-in date and timing will come after the final lease signing. D. Nuzzi is working with A. Petrin, E. Hager, and the real estate agent to draft a lease that all can agree on.
- Staffing there are two positions currently open, and candidates being sought O2 Community
 Partnerships and a Development Associate. L. Stauffer has returned as a contract employee to write grant
 and relief funding proposals.
- The season preview Part 2 was live at Merrill Auditorium on September 9th. Ticket sales to many events were launched for members and new memberships were solicited. The new program "brochure" is a one-page fold out presented in calendar format. Additional events can be added to the season if viable. A lot of the programming this year was planned for the last year. Our theme for this year is "home" and this will be interpreted in many ways. The Seeking Resonance series will be in conjunction with Indigo Arts Alliance and expand on the "Home" theme with Black, Brown and Indigenous artists. Our commissioned artists will present finished or partial programs throughout the year.
- The season opening events will be live and outdoors with Bandaloop on October 8th and Dan and Claudia Zanes at Portland Schools on October 15th and in Deering Oaks on Oct. 16th.
- New sponsors and old are stepping up to finance specific shows and events. Members are sharing social media and email postings about the season and building the buzz.

M. Stillings presented Treasurer's Report

- The financial reports are attached. They show the good news that revenue from grants and relief funding has kept our finances strong. The forgiveness of the 1st Pandemic Protection Plan (PPP) loan and generous donors have helped to replace the normal ticket revenue. The Balance sheets shows assets up over 1.1 million from last year.
- The Finance Committee is preparing to undertake a risk analysis involving costs and no revenue in several key program areas to help ensure that the financial situation stays in control.
- The Finance Committee will also turn to its audit oversight role during the next month.

M. Boyson presented the Development Committee report starting with a short discussion of the Letter of Agreement and Conflict of Interest statement that are being combined and will not have a dollar value listed though in person discussions will emphasis that the Board are expected to make Portland Ovations a key part of their giving strategy.

- The topic of accepting or even soliciting sponsorships/donations from Marijuana businesses was discussed. This was compared to discussions years ago when the arts organizations did/did not support accepting money directly from tobacco companies. Foundation grants and donations from individuals who earned their money from tobacco were accepted but no money came from sources directly tied to a current tobacco company. There is concern with public acceptance especially when it comes to school or family-oriented programming. How does this tie into inclusion and equality?
- Mary Noyes offered to send information about medicinal marijuana for further discussion.
- The topic was tabled at this time but should be discussed yearly.
- Looking forward to "over the Bridge" with no plans for another public campaign this year. Watching for "donor fatigue" as we continue to build our membership and keep our big donors in the picture.
- On the dashboard SVOG is not yet listed. It makes the numbers look very good.

T. Powers introduced the annual fundraiser which will be held on Jan. 6^{th} – a new year and a new format. The event will be at the O'Maine Studios with limited tickets and special performers, food demo's, audience participation and an auction.

- The teaser: Join Portland Ovations in creating community through the sharing of food, art and performance in an intimate, active, dynamic and relational experience that is wholly unique to Ovations & our commitment to gathering people, sharing cultures and live performances."
- Featured performers are the dynamic Azerbaijani pianist Emil Afrasiyab and his lovely wife Leyla with soulful and skilled music inspired by jazz, classical and global music.
- VIP pre-event will feature a hands-on cooking lesson and food and beverage stations will highlight the international reach and diversity of Ovations programs. A mini dance lesson will also be included.
- Money will also be raised through a select live auction and a reverse auction showing casing the educational programs. Sponsors and Board member support are needed.
- T. Powers will be looking for task force member to help make this a reality.

P. Genova gave a quick update on the progress of the Strategic Planning Task Force. The draft of the plan is being prepared and work is moving into how the plan will be implemented by the staff and Board.

O. te Boekhorst introduced the resolution the COVID response Team is asking the Board to make. (See attached.). As the meeting was running late this will also be presented via email to the Board members. A quorum was present. O. te Boekhorst moved that the Board agree to be 100% vaccinated as are the staff. This shows a commitment to the vaccine requirement for public audiences. The motion was seconded by J. Lufkin and there was general agreement. No-one opposed the motion.

An email vote was sent to the entire board following the meeting. Final vote: 18 Yes, 1 No.

M.A. Lindemann ended the meeting by thanking everyone for coming and reminding us to invite people to join our events. We need people in the seats.

The meeting ended at 1:50 p.m.

Development Plan Summary for Portland Ovations 2021-22: September 2021 TOTAL Goal: \$1,035,980

Our focus is major giving and activating Dev Steering to prepare for solicitation. Our annual appeal is planned to mail on November 15 and will focus on October performances and the impact of Ovations in the community. We continue to work hard for corporate sponsorships and confirm those as efficiently as possible. We are about the begin soliciting sponsors for the Annual Fundraiser. If you have a corporate contact - please put us in touch with them. The -\$500 in events represents a write off for an unpaid sponsorship from Morgan Stanley in March of 2020. Grants are well covered by Laura Stauffer. The variance in grants from FY21 to FY22 is due to reflief funding hitting in the FY21 line but being broken out seperately for FY22. We have included FY22 relief funding on a seperate line.
